## Mayor's Office seeks to build the strongest early childhood workforce in the country

Answers to new state survey will offer frank look at school quality

Calling it an "X-ray" of public schools, Illinois is launching an unprecedented attempt to gather candid information on how teachers are teaching, students are learning and principals are leading.

Guaranteed to make for some potent reading — and already causing trepidation among educators — the data will be pulled from a statewide survey that could include more than 1 million students and 100,000 teachers beginning Feb. 1.

the effort is meant to provide rooms, officials say.

- Does the teacher ask difficult questions on tests?
- How often do you debate the meaning of a reading?
- How often do you write a few sentences to explain how you solved a math problem?

Teachers will be asked, essentially, to rate their principal, responding to this statement among others:

"The principal at this school is an effective manager who makes the school run smoothly."

The survey has caused consternation in part because respondents will be anonymous. Cloaked in anonymity, "you might go a little further than otherwise if you knew your comments were attached to you," said Jason Leahy, executive director of the Illinois Principals Association.

# Research Values & Criteria



EC-REACH supports research that is:

Value	Criteria
<b>Rigorous</b>	Research will meet high standards in qualitative, quantitative, and mixed methodologies and will be committed to an open science practice
<b>Responsive</b>	Research will be solutions oriented and provide timely insights that are responsive to the pressing issues facing early childhood policy and practice
<b>Equitable</b>	Research will prioritize an equitable and asset-based approach that addresses the bias of power and privilege and engages community perspectives (especially those from historically disadvantaged and underrepresented groups) to shape the entire research process.
<b>Collaborative</b>	Research will be conceptualized, designed, and implemented through balanced and pre-determined collaboration among research partners, policy partners, practitioners, community leaders, and families.
<b>Inclusive</b>	Engage researchers, policymakers, and practitioners who approach their work from a variety of perspectives; we will be especially intentional about including researchers from historically disadvantaged and underrepresented groups as so to develop a more inclusive pipeline for the systemic work.
<b>Contextualized</b>	Research will be grounded in Chicago's social, economic, and political context.
<b>Accessible</b>	Communicate findings to diverse audiences (locally, state-wide, and nationally), using a variety of mediums, to encourage the use of research to inform meaningful change in policy and practice.

# Data Access & Sharing Discussion

- Does EC-REACH own/manage the actual data acquisition process, or instead support individual RPP/study teams to do so? What is each individual RPP/studies' role in gaining access to data?
- Does EC-REACH set up standing master data use agreements with agencies/ organizations with administrative data or instead support streamlined but separate data use agreements for specific research studies?



# Data Access & Sharing Pillars



EC-REACH should not collect or manage administrative / accountability data or data dashboards, but should instead:

Pillar	Explanation
<b>Data Type</b>	Support research studies that use administrative data, and studies that include primary data collection including qualitative data.
<b>Data Access</b>	Facilitate access to existing early childhood data, including administrative and accountability data that may include providing language and templates for partners to put data use agreements in place and/or establishing master data sharing agreements with one or more agencies/organizations. Subject to authorization by data owners.
<b>Data Sharing</b>	Facilitate access to a growing body of new early childhood data by facilitating the sharing of data, documentation, and prepared administrative data for analysis among current and past EC-REACH partners.
<b>Data Linking</b>	Facilitate the ability to link early childhood data from various sources, including via streamlined/expedited access to the CECIDS dataset. <ul style="list-style-type: none"><li>○ CECIDS will provide integrated data, data modeling, and a secure research environment for EC-REACH.</li><li>○ EC-REACH projects will identify the need for improved and additional data to incorporate into CECIDS</li></ul>
<b>Review and Approvals</b>	Adhere to home institution IRB approval process and support partner IRB approval processes, including supporting approvals by data owners.

# Home Institution(s) Selection Criteria



In addition to supporting the mission and research values of EC-REACH, we are looking for a home institution that is:

Criteria	Explanation
<i>Flexible support</i>	Understands and has the capacity to fully realize the power of a citywide early childhood research alliance, including its need for self-governance, flexibility, transparency, and participatory ways of working.
<i>Cross-sector representation</i>	Maintains a broad focus to support work across all sectors of the early childhood system in Chicago, including early care, education, home visiting, and maternal & child health
<i>Operations Backbone</i>	Provides infrastructure to support functions such as: contracting, compliance, data sharing and use agreements, institutional review board approvals, office and meeting space, payroll, benefits, IT support, partnerships/MOUs.
<i>Outreach engine</i>	Shares support for fundraising and bolsters connections to funders; capacity and expertise to uplift communication/dissemination.
<i>Mission alignment</i>	Leadership brings energy, enthusiasm and an entrepreneurial spirit to the undertaking; and has demonstrated a focus on equity and inclusion.
<i>Public trust</i>	A stable and durable institution that has earned the trust of Chicago's early childhood researchers, policymakers, practitioners, communities, and families and is well-positioned to act as a hub and convener across these groups.
<i>Broad reach</i>	Maintains and facilitates strong connections to state and national work.
<i>Research Expertise &amp; Capacity</i>	Is experienced in and committed to both conducting rigorous and actionable early childhood research and supporting partners to do so.

# Defining Various Working Bodies

TYPE	DEFINITION	RESPONSIBILITIES	INVOLVEMENT
<b>Planning Committee</b>	Small group of key decision makers that meet for a short, time-bound period	Planning Committees help stand up a new collective effort with the sustainability model at the forefront.	Mar-June (20 hours) July-Aug (5 hours)
<b>EC-REACH Staff</b>	Individuals employed by EC-REACH to lead and coordinate the work	EC-REACH staff will provide content knowledge and serve as a neutral interest to pursue the mission and vision of EC-REACH.	Daily (starting Fall 2022)
<b>Steering Committee</b> (Advisory Board)	Ongoing agenda-guiding body that moves the work of a collective effort (Research Advisory Council or Coalition) forward by determining priorities of the organization	Steering committees provide advice, ensure delivery of the project outputs and the achievement of project outcomes. <i>Members do not usually work on the project themselves.</i>	Ongoing biweekly meetings beginning in June 2022

## UChicago Consortium on School Research

The Consortium's Steering Committee is made up of institutional (Illinois State Board of Education, the Chicago Public Schools, and the city's Board of Education, Teachers Union, and Principals and Administrators Association) and individual members (civic leaders, education researchers, and members of education-reform, advocacy, and service organizations).

The Committee works with Consortium staff to develop a research agenda and review research in progress.

## Chicago Biomedical Consortium (CBC)

CBC is a collaboration between scientists at Northwestern, U of Chicago, and UIC. It has an Executive Oversight Board providing general oversight and holding the CBC accountable for achieving its goals.

It is composed of representatives from the funding agency (The Searle Family and The Chicago Community Trust), the three universities, and the biomedical industry.

CBC also has a Scientific Advisory Board composed of scientists outside of Chicago, an Accelerator Review Board composed of representatives from the pharmaceutical industry, and a Catalyst Review Board which oversees the Catalyst Award program.

# Governance Model Example

## Boston P-3 Research-Practice Partnership

This is an IES-funded RPP between Boston Public Schools and American Institute of Research (AIR). Together, the two organizations developed a plan that would become the ground rules for a partnership.

The plan placed the common needs and research questions at the center of the effort, as well as a system for checking the health of the partnership at several points in the process.

Finally, it included an advisory group representing key district constituencies (e.g., researchers, school principals, parents, etc.) to keep the partners focused.

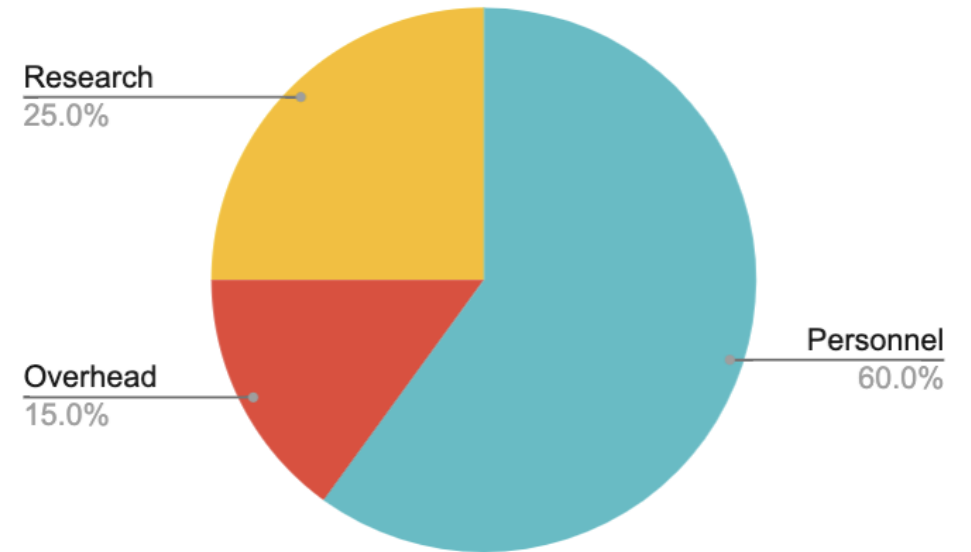

# Operating Budget Discussion

- How many research projects will be conducted/supported on average annually?
- Year 1 operating budget considerations:
  - Revenue
    - Philanthropy - Individuals, corporations, foundations
    - Federal, state, & local government grants
  - Expenses
    - Personnel – FTE staff (30% administrative – fundraising, operations, communications, 70% research support)
    - Overhead – facilities, supplies, insurance, etc.
    - Contracted Research
  - Future considerations
    - Contracted Services, Travel, Professional Development, Technology, etc.

# Possible Home Institution Selection Process

What happens after possible home institutions have been identified?

## RFP PROCESS

1. Identify list of all potential institutions
2. Possibly narrow based on criteria
3. Craft & share RFP aligned with criteria
4. Working group scores proposals
5. Best-fit institution is selected

## RECRUITMENT PROCESS

1. Identify list of all potential institutions
2. Planning Committee hosts discussions to probe alignment with criteria
3. Narrow list based on findings
4. Working group deepens exploratory conversations
5. Best-fit institution is selected

## OTHER?

1. Identify list of all potential institutions
2. Secure funding
3. Open letter of inquiry process
4. Score & Narrow list
5. Invite smaller # to apply to RFP aligned with criteria
6. Working group scores proposals
7. Best-fit institution is selected
