This workshop highlights Illinois' journey integrating Moving Beyond Depression (MBD) within its home visiting system. Presenters will share implementation lessons, adaptations, and early outcomes showing MBD's role in improving family well-being, empowering home visitors, and fostering community-level change.

This session is Ideal for policymakers, funders, and home visiting system leaders seeking strategies to embed mental health interventions within existing infrastructures, address barriers to care, and promote cross-sector collaboration for family well-being.

This workshop will share Illinois' experience in weaving Moving Beyond Depression (MBD) into the fabric of its state home visiting system in order to impact multiple levels of the care system. We will share critical components in preparing for implementation, note some hurdles and adaptations to challenges, and detail the preliminary positive impact - for families, within organizations, and across systems and communities.

Home visiting programs in IL have incorporated routine screening depression tools into program services for some time now. The increased rates of identification of, and referrals for, women with depression have served to heighten awareness of the systemic barriers that inhibit access to mental health treatment. Given MBD's proven track record of overcoming such barriers, the model seemed a natural fit for our home visiting system.

Beyond the immediate goal of increasing access to treatment, the workshop will explore the role MBD is playing in strengthening programs by supporting and empowering home visitors in their role, consequently improving program



outcomes. We will also look at MBD as a tool to help us realize our goal of effecting community change. Two of our four MBD communities have universal home visiting programs – embedding MBD in these programs will advance their goal of greater community alignment and, we hypothesize, the resulting positive ripple effects of such large scale community support will reverberate throughout the communities.

Opening (10 minutes): At the beginning of the session, we plan to show Ed Tronick's still face video (which is slightly under three minutes) to underscore the impact of maternal depression on the baby. Following the video, we will invite participants to reflect on what they observed and connect those observations to their professional experiences.

Interactive Group Discussion (10-25minutes): We will then ask the program staff in the audience about their experience in moving participants from positive screening to diagnosis to referral to engagement in treatment and ask all to articulate some of the barriers that exist that prevent people from accessing treatment. We'll talk about the different levels at which barriers exist: individual, community, and societal.

Core Presentation (25-50 minutes): The presentation will describe Illinois' journey integrating Moving Beyond Depression (MBD) within its statewide home visiting system

Closing and Q&A (50-60 minutes) minutes). We'll end with an open Q&A and group reflection (about 10 minutes) to bring the session's ideas together. Participants will be invited to share key takeaways, ask questions, and name one idea they plan to bring back to their own work.

Throughout the session, facilitation will emphasize reflective practice, parallel process, various adult learning principles.
